

PRIVACY POLICY

1.Introduction

1.1 This Privacy Policy deals with how KJ Industries, deals with your personal information.

These terms are effective immediately.

1.2. Should you decide to register as a user on the Website, we may require you to provide us with personal information which includes but is not limited to -

- i. your name and surname;
- ii. your email address;
- iii. your physical address;
- iv. your gender;
- v. your mobile number; and
- vi. your date of birth.

2. Information we collect

2.1 When you visit www.textrader.co.za, we may harvest the following data: your IP address; your ISP; the date and time and length of your visit to www.textrader.co.za; the pages you accessed; the number of times you access www.textrader.co.za; the website which referred you to www.textrader.co.za; the operating system you use; your location; and other metadata.

2.2 When you contact us, fill in forms, become a member or use www.textrader.co.za as a member, we may also collect the following from you: personal details, including your name, address, email address, mobile number, financial details, transactional details.

3. Our use of your information

3.1 This information is used for statistical purposes, to target advertisements, to improve our services and products sold on www.textrader.co.za and provide smooth, efficient and customized access to www.textrader.co.za and to provide a safe and reliable platform for buyers and sellers.

3.2 You agree that KJ Industries may use your personal information to provide services; resolve disputes; collect fees; facilitate payment and billing; verify and assess notes; customise, prevent, detect and investigate actions potentially in breach of the law or www.textrader.co.za terms and conditions; conduct surveys and other research.

3.3 You agree that KJ Industries may use your personal information to contact you and to deliver targeted marketing materials to you about www.textrader.co.za. You can inform KJ Industries if you do not wish to receive further marketing materials from us. There is no cost for this service and opting out will not affect your use of www.textrader.co.za .

3.4 Our disclosure of your information to others

3.5. We will -

- i. treat your personal information as strictly confidential;
- ii. take appropriate technical and organisational measures to ensure that your personal information is kept secure and is protected against unauthorised or unlawful processing, accidental loss, destruction or damage, alteration, disclosure or access;
- iii. not disclose your personal information to third parties for their marketing purposes.
- iv. provide you with access to your personal information to view and/or update personal details;
- v. promptly notify you if we become aware of any unauthorised use, disclosure or processing of your personal information;
- vi. provide you with reasonable evidence of our compliance with our obligations under this policy on reasonable notice and request;
- vii. upon your request, promptly return or destroy any and all of your personal information in our possession or control; and
- viii. not retain your personal information longer than the period for which it was originally needed, unless we are required by law to do so, or you consent to us retaining such information for a longer period.

3.6 You agree that KJ Industries may disclose your personal information to payment partners for the purpose of facilitating transactions.

3.7 You agree that KJ Industries may also disclose your personal information to service providers or any business entity should we plan to merge with or be acquired by that entity.

3.8 KJ Industries may also disclose your personal information to any person if we are authorised or required to do so by law.

3.9 KJ industries employs tools (including passwords and physical security) to protect your personal information.

3.10 Whilst we will do all things reasonably necessary to protect your rights of privacy, we cannot guarantee or accept any liability whatsoever for unauthorised or unlawful disclosures of your personal information, whilst in our possession, made by third parties who are not subject to our control, unless such disclosure is as a result of our gross negligence.
